HONORING DR. PAUL S. FARSAI

Dr. Paul S. Farsai will be honored as the recipient of the Thomas F. Winkler Award at the 2022 ACD New England Section Annual Meeting for his leadership and dedication to our profession and to the New England Section.



Dr. Paul S. Farsai

Dr. Farsai was inducted into Fellowship in the American College of Dentists in 2006. Following his undergraduate studies at the University of Washington, he moved to Boston and received his D.M.D. degree in 1994 from the Boston University Goldman School of Dental Medicine. He subsequently completed a 1-year Advanced Education in General Dentistry residency and a 2-year Faculty Training Fellowship in Geriatric Dentistry from B.U. While in the Geriatric Dentistry Fellowship program he was enrolled in and received his Masters in Public Health degree from the Boston University School of Public Health with a concentration in Social and Behavioral Sciences-Health Promotion/Disease Prevention. After finishing his professional training in 1997, he became a faculty member at B.U. and currently serves a a Clinical Professor in the Department of General Dentistry and Program Director in Behavioral Sciences, Practice Management and Evidence-Based Dentistry. He teaches both pre- and post-doctoral students and maintains a solo private practice in Swampscott, MA.

In 2001-2002 Dr. Farsai was one of 13 faculty members selected nationally for the prestigious 1-year Fellowship to the American Dental Education Association Center for Educational Policy and Research's Leadership Institute to train individuals for higher education administrative positions, becoming the youngest LI Fellow ever admitted to the program . He was the recipient in 2005 of the Massachusetts Dental Society "10 under 10" Award awarded 10 Massachusetts dentists each year who have made significant contributions to the profession, community service, and organized dentistry within the first 10 years of their dental school graduation. In 2005, he was elected to the OKU National Dental Honor Society as a faculty member of the Boston University Lambda Mu Chapter. He was also selected for Fellowship in the Pierre Fauchard Academy.

Professionally, Dr. Farsai has served as a consultant to various dental insurance plans/companies, as an adviser to a multinational pharmaceutical oral health care advisory board, as the State Coordinator for Massachusetts for the Special Olympics Special Smiles dental screening program, and as an expert consultant to the Board of Registration in Dentistry. Currently he works with law firms in New England, New York, and New Jersey as an expert consultant reviewing legal malpractice cases. In conjunction with UMass Boston and the Eunice Kennedy Shriver Center at UMass Medical Center, he has served as an educational consultant to media consulting firms developing education materials for families of individuals with special needs.

In academics, he was appointed to the ADEA Presidential Commission for Mentoring and served on development committees for endowed professorships at B.U. He has served on the ADEA Leadership Institute Alumni Association Administrative Board as well as Yankee Dental Congress Scientific Committees and has coordinated student table clinics for many years. From 2009 to 2017, Dr. Farsai was invited to join the ADA's Center for Evidence-Based Dentistry serving as one of thirteen national and international reviewers and editorial panelists to teach critical appraisal skills in reading and writing scientific literature for dental school faculty in both the U.S. and Canada. And in 2013, he was appointed to a 1-year term as Consultant to the ADA Council on Scientific Affairs. Dr. Farsai has authored over 35 peer-reviewed articles, and book chapters.

Dr. Farsai has an extensive volunteer record in various dental associations, planning and organizing numerous educational programs for his fellow dental professionals. He has lectured in the U.S., The U.K., Canada, Japan, and the UAE on evidenced based dentistry, geriatric dentistry, special needs dentistry as well as dental education teaching modules. He also serves on the editorial boards of several professional journals and is a manuscript reviewer for eleven international dental journals.

Dr. Farsai's dedication to our profession, professional education, and his steadfast commitment to the principles defined in the ACD Mission Statement are exemplary. It is an honor for us to bestow the Thomas J. Winkler Award on him.

Nominate A Deserving Colleague For Fellowship

The American College of Dentists through our New England Section seeks nominations for Fellowship. A nomination is a gift you can bestow upon a meritorious colleague and it is both a distinction and an honor. Entrance into the College is only through that nomination process and the College depends upon our Fellows to identify those individuals worthy of recognition.

These nominees, be it through teaching, research, dental organization participation, or community service, have advanced excellence, professionalism, and leadership. These are the core principles embodied in the mission statement of the College. Nominees can be from New England as well as anywhere in the United States, Canada, or internationally. The College encourages nominations from all area of the profession and with a broad range of experience from newer professionals to those with many years of experience.

The nomination process is confidential and can be accomplished by email, fax, or mail. The nominee should be asked for their curriculum vitae without revealing that it is for the purpose of Fellowship nomination but rather that they are being nominated for an award. A Fellow familiar with the applicant should serve as a seconder. The nominees are then reviewed by a committee of the ACD Board without knowledge of the name of the nominee, the nominator or the seconder.

The deadline for nominations for induction at the next annual meeting is January 15, 2022. The nominating forms and the profile summary can be downloaded through the ACD website after logging on to the Members Section and completed after obtaining the curriculum vitae. The completion of the forms requires a statement from the nominator and should be seen by the seconder. The statement is a critical part of the process for the committee reviewing the Fellowship application. Please do not forward any part of the completed application materials to the person being nominated as that is a violation of the ACD confidentiality requirement. New England Section YDC Panel Discussion Presentation

Multidisciplinary Treatment Planning in Recognizing and Resolving Ethical Issues

Dentists face professional and ethical dilemmas on a daily basis. Along with dentists, dental hygienists and dental assistants participate in the resolution of these dilemmas as part of the dental team. On Thursday, January 27, 2022 the New England Section will present the above titled course, continuing its series of clinical ethical/legal presentations at the Yankee Dental Congress. The panel discussion will focus on the recognition of treatment planning shortcomings with the corresponding potential for risk management issues. By using actual clinical cases that involve multi-disciplinary treatment planning approaches, this course will encourage audience participation (dentists, hygienists, assistants) in order to demonstrates how to recognize ethical dilemmas and how these concerns were actually addressed with subsequent clinical treatment. Certain legal as well as the risk management ramifications of the treatment avoided as well as the treatment rendered will be discussed.

Course attendees will be able to:

- 1. Understand how the dental team (dentist, hygienists, assistants, and front desk managers) can work together to recognize ethical dilemmas guided by the ADA Ethical Principles.
- 2. Recognize how the dental team addresses patients' concerns about treatment to resolve ethical dilemmas.
- Utilize interdisciplinary treatment planning to help limit ethical issues and treatment problems.
- Examine ways to render subsequent clinical treatment that can mitigate risk problems and legal concerns.
- 5. Determine how to strengthen the dental team's risk management skills.

The panel participants will be:

Vincent Dunn, Esq, JD concentrates his practice on health professionals and institutions in civil, criminal, and administrative matters. He lectures on risk management, regulatory compliance, administrative procedures, and professional licensing issues. He has appeared in state and federal courts before Boards of Professional License Registration and at regulatory and credentialing hearings and investigations.

Dr. Howard Hill, DDS is a Past Chairperson of the New England Section and maintains a full-time restorative practice in Georgetown, MA.

Dr. Roger Wise, DDS is a faculty member in the Department of Periodontics at the Harvard University School of Dental Medicine.
